Saheed Bello is a Postdoctoral fellow at the School of Languages, Cultures and Linguistics, SOAS University of London, UK, and a guest researcher in African Philosophy in the Department of Philosophy, Vrije Universiteit Amsterdam, The Netherlands. He was an international fellow at the Bayreuth Academy of Advanced African Studies, University of Bayreuth, Germany. Dr. Bello holds a Ph.D. from the Department of Creative Arts, University of Lagos, Nigeria, with a designated emphasis on narrative adaptation from Nigerian literature into film. His research focuses on African Literary and cultural studies, film and philosophy, African philosophy and post/decolonial theory, eco-spirituality, and environmental sustainability. His recent publications include “Ọ̀rúnmilà Epistemic Reproduction: Nigerian Film Philosophy via Divinity and Orality” (2022), “Ọ̀rúnmilà, and the Yorùbá Intellectual Tradition: Words and Language vis-à-vis Western Modernity” (2023), and “Ọ̀rúnmilà Film-Philosophy: Aesthetics of Èjìgbèdè Ẹ̀ kú in Saworoide” (2023). His forthcoming research article, “The Fourth Cinema: Morality, Spirituality, and Tragedy in African Cinema,” has been accepted in the *Journal of Aesthetic Education*.
